145.211 Forms

Under the New Rule there is provision for maintaining forms used in the maintenance and inspection of articles. The repair station that takes advantage of this provision can

perform maintenance on forms without throwing the Repair Station Manual into revision. Forms change as companies grow and take on new capabilities.

The new rule allows for change in forms without the added hassle of regulatory oversight. To comply with the regulation it is necessary to create a Forms Manual or Forms Log. A Quality Control Procedures and appropriate Work Instructions is necessary to describe how each form is maintained. This is a good way to avoid revisions, and at the same time streamline the maintenance processes associated with *maintaining forms*.

145.215 Capability List

The New Rule allows repair stations to add to their Capability List through a self evaluation. This involves developing a new process to perform a "self evaluation." This may be especially helpful for companies that have the potential to add several new items to their Capability List. It certainly offers a streamline way of to take advantage of new business opportunities.

AC 145-9 (1-2 d.) Electronic Submission

Disbursement of manuals has never

been easier. Open up an e-mail, attach your document and hit the Send Button. It is almost that easy. Revision, disbursement of documents.

acknowledging receipt of documents are easily accomplished with just a little e-mail know how. No more insertion of pages for a revision. Just send the complete document!
